Scrutiny assist

In 2022-23 we launched Scrutiny Assist. This is simply a list of Cottsway customers who sign up to help us on scrutiny reviews. We've been fortunate that some have come forward for this and one is currently helping us with the damp and mould review. We look forward to working alongside them in the year ahead.

Communal repairs

We're proud to have completed a review of the communal repairs service. We looked at other similar sized housing associations to compare their standards to those of Cottsway, carried out a customer survey and interviewed five people to better understand their experiences.

We made ten recommendations for service improvements and are pleased to see the improvements Cottsway has achieved so far. We'll keep monitoring progress with this action plan in the year ahead. You can view the recommendations on Cottsway's website at:

We also completed our latest assessment of how well Cottsway are delivering on their commitment to the

Update on previous scrutiny reviews

The ASB (anti-social behaviour) report actions are now complete. This review still remains one of our best scrutiny reviews and we're so proud that this piece of work has made such a difference. We continue to be updated from Cottsway on any changes that occur within the ASB service and on the ASB webpage.

Training and development



We continue to receive training and support from an external trainer on IT issues as well as in-house support. We regularly attend webinars

and conferences with the Tenant Participation Advisory Service, known as Tpas, and we keep abreast of current legislation and laws by joining online webinars with the Regulator of Social Housing and the Housing Ombudsman. Some of us have also attended conferences which enabled us to meet up with delegates from many other scrutiny groups from across the country. We're looking forward to attending the next Tpas conference in July.

Tenant Satisfaction Measures

In 2021-22 we took part in the Regulator of Social Housing's consultation on the proposed Tenant Satisfaction Measures (TSM) and are pleased to report these have now been finalised and launched. The TSM's will make a big difference when the results are published next year as they will enable all residents of social housing to see how their landlord is performing in comparison to others.
